

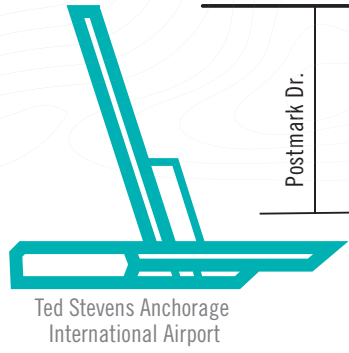
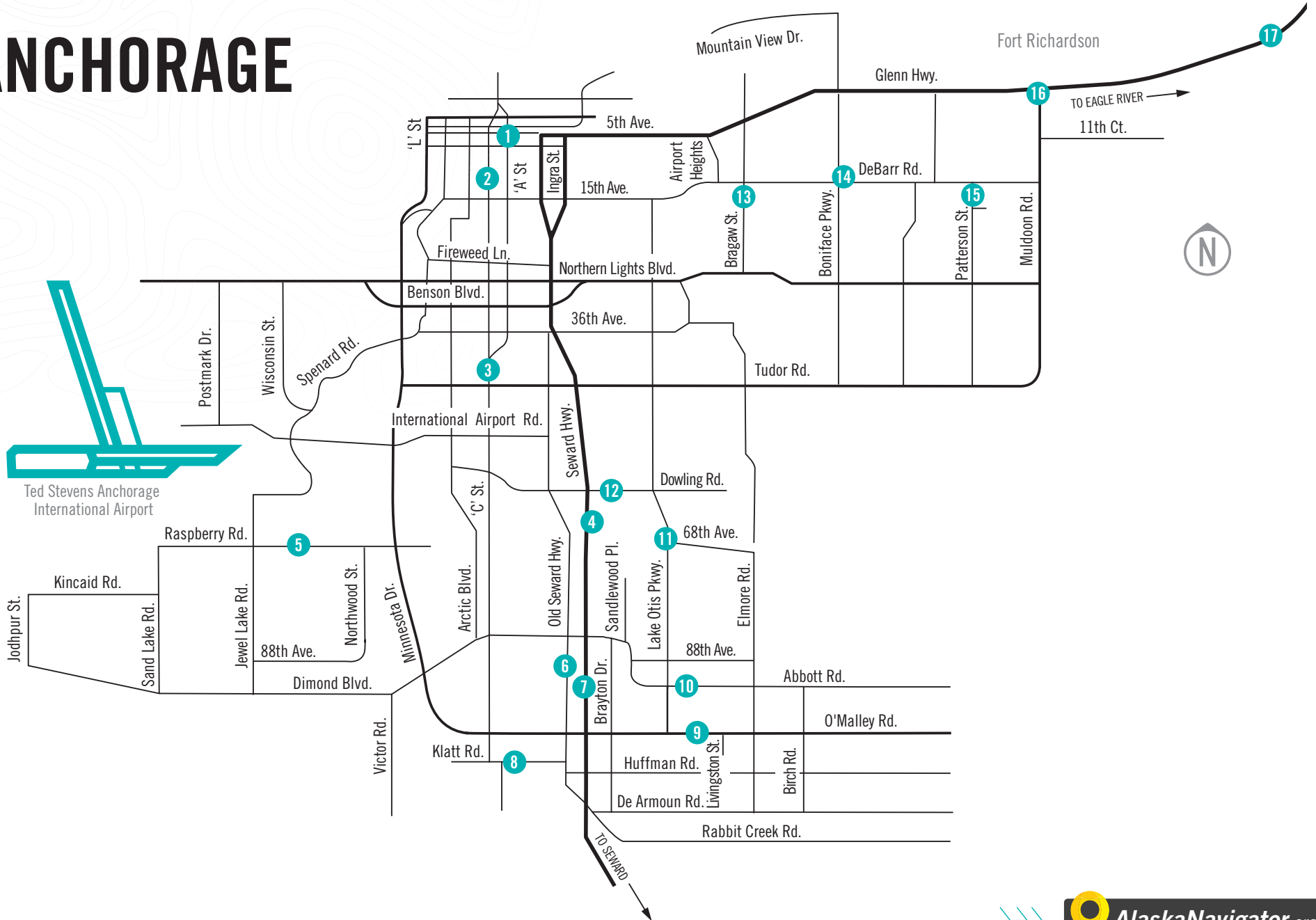

# ANCHORAGE CONSTRUCTION

**1 'A' and 'C' STREET RESURFACING, 9TH to 6TH AVENUE**  
Construction Manager: Steve Jochens (907) 269-0659  
Contractor: QAP  
Paving 'A' and 'C' street, 9th Avenue to 6th Avenue and replacing curb ramps as needed.

**2 AMATS: 'C' STREET, 10TH AVENUE to 40TH AVENUE BICYCLE PLANS**  
Construction Manager: Brian Schumacher (907) 269-0432  
Contractor: Roger Hickle Contracting, Inc.  
Constructing various bicycle facilities recommended by the Anchorage Bicycle Plan on DOT&PF owned roadways within Anchorage, Eagle River and Birchwood.

**3 'C' STREET, PORT ACCESS ROAD to 40TH AVENUE PAVING**  
Construction Manager: Steve Jochens (907) 269-0659  
Contractor: QAP  
Repaving the existing roadway, upgrading curb ramps, signage and guardrail, improving safety and drainage, and bridge decks as needed.

**4 SEWARD HIGHWAY, DIMOND BOULEVARD to DOWLING ROAD RECONSTRUCTION**  
Construction Manager: Steve Jochens (907) 269-0659  
Contractor: QAP  
Reconstructing the Seward Highway from four to six lanes from Dimond Boulevard to Dowling Road. Improving frontage roads and Sandlewood Place, including adding multi-use trails. Constructing two bridges to separate the New Seward Highway over 76th Avenue.

**5 RASPBERRY ROAD, JEWEL LAKE to MINNESOTA DRIVE PAVEMENT PRESERVATION**  
Construction Manager: Alan Drake (907) 269-0665  
Contractor: Granite Construction  
Resurfacing Raspberry Road from Jewel Lake Road to the Minnesota Drive northbound off-ramp and expanding the road to include a dual left-turn lane helping to mitigate angle collisions.

**6 SEWARD HIGHWAY, 92ND AVENUE CONNECTOR PHASE I**  
Construction Manager: Brian Schumacher (907) 269-0432  
Contractor: Bristol Construction Services, LLC  
Constructing a southbound auxiliary lane from Dimond Boulevard to 92nd Avenue and from 92nd Avenue to O'Malley Road including new traffic signals and creating a connection from the Old to New Seward Highway.

**7 HSIP: GLENN HIGHWAY and SEWARD HIGHWAY PEDESTRIAN SAFETY FENCING**  
Construction Manager: Ron Searcy (907) 269-0656  
Contractor: Granite Construction  
Constructing two segments of pedestrian safety fencing at two separate controlled access corridors, Glenn Highway and Muldoon Road and Seward Highway at 92nd Avenue.

**8 HSIP: KLATT ROAD and JOHNS ROAD INTERSECTION IMPROVEMENTS**

Contractor: QAP  
Implementing a single lane roundabout to mitigate crash pattern.

**9 AMATS: O'MALLEY ROAD RECONSTRUCTION: PHASE 1 SEWARD HIGHWAY to LIVINGSTON STREET**

Contractor: QAP  
Reconstructing O'Malley Road from the Seward Highway to Livingston Street. Work includes grading, drainage, paving, pathways, signage, striping, illumination and signalization.

**10 AMATS: ABBOTT ROAD REHABILITATION PHASE I**

Contractor: QAP  
Rehabilitating road surface, widening to a continuous two-way lane, adding a second eastbound through-lane at Lake Otis Parkway, improving curves and rehabilitating existing pathway from Lake Otis Parkway to Jupiter Drive.

**11 HSIP: LAKE OTIS PARKWAY at 68TH AVENUE CHANNELIZATION**  
Construction Manager: Ericka Moore (907) 269-4550  
Contractor: Pending  
Enhancing safety of intersection with channelization modifications including widening of the roadway, raised medians and signal work.

**12 DOWLING ROAD: OLD SEWARD to LAKE OTIS PARKWAY PAVEMENT PRESERVATION**

Contractor: Pending  
Resurfacing Dowling Road from the Old Seward Highway to Lake Otis Parkway, including, as necessary, improvements to curb ramps, dig outs, drainage repair, sign replacement and striping.

**13 HSIP: BRAGAW STREET at 16TH AVENUE**

Contractor: QAP  
Improving safety by widening Bragaw Street, creating a two-way left turn lane between 16th and Debarr Road and installing raised medians.

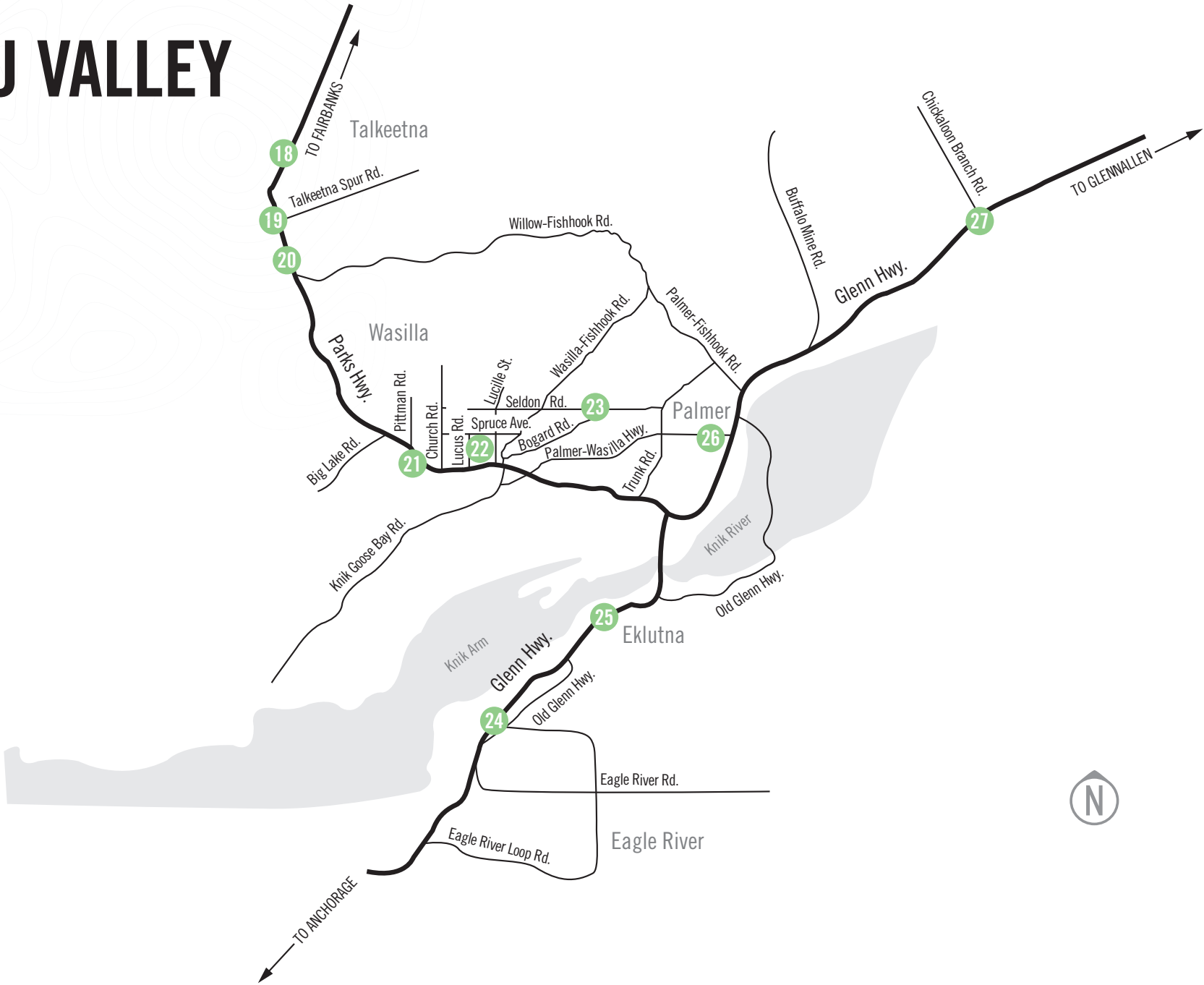
**14 AMATS: BONIFACE PARKWAY, DEBARR ROAD and CARRS DRIVE PEDESTRIAN PLAN**  
Construction Manager: Brian Schumacher (907) 269-0432  
Contractor: Mass Excavation, Inc.  
Constructing sidewalk improvements on the east side of Boniface Parkway from Debarr Road to the southernmost Carrs driveway.

**15 AMATS: PATTERSON STREET, DEBARR ROAD to CHESTER COURT**

Contractor: Mass Excavation, Inc.  
Constructing sidewalk improvements on the east side of Patterson Street from Debarr Road to Chester Court.

**16 GLENN HIGHWAY and MULDOON ROAD INTERCHANGE**

Contractor: Neeser Construction  
Reconstructing the Glenn Highway/Muldoon Road Interchange and replacing existing roadway with a Diverging Diamond Interchange, including bike and pedestrian amenities.

Resurfacing the Glenn Highway from the Airport Heights Drive intersection to the Hiland Road interchange, a distance of approximately 10.5 miles.

## HSIP: PARKS HIGHWAY, PASSING LANES MP 99 to 123.5

Contractor: Pending

Project will add one mile passing lanes along the Parks Highway beginning from MP 99 to 123.5. New passing lanes will be spaced every 6-10 miles and will coordinate with current Parks Highway projects.

## PARKS HIGHWAY, TALKEETNA SPUR ROAD PEDESTRIAN IMPROVEMENTS

Contractor: Pending

Pedestrian safety improvements near the Parks Highway/Talkeetna Spur Road intersection.

Improvements include: 1) a lighted Parks Highway underpass from East Helena Avenue to the north side of the Susitna Valley Middle/High School driveway, 2) a pathway on the east side of the Parks Highway from the underpass north to the Talkeetna Spur Road, and 3) a painted sidewalk across the Talkeetna Spur Road connecting the improvements to the existing bike path.

Planned improvements include resurfacing, shoulder widening, drainage, signing, guardrail, re-striping and new rumble strips.

Upgrading the Parks Highway to a four-lane divided highway with intersections spaced every half mile, improving existing frontage roads and reconstructing the pedestrian pathway. Project includes lighting and a bridge replacement over the Alaska Railroad.

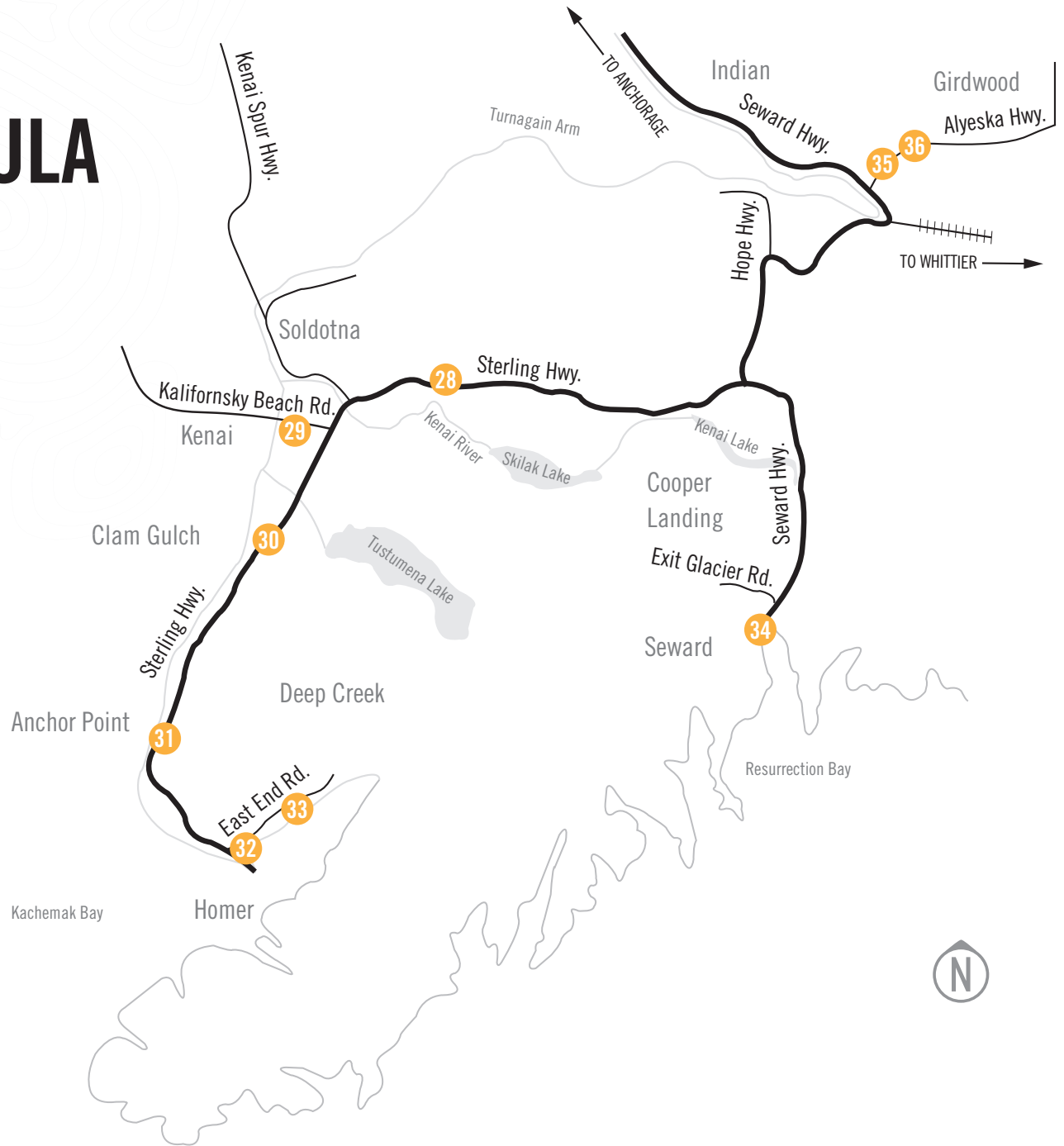

Project will rehabilitate the Sterling Highway from MP 58-79. Improvements to include resurfacing, widening shoulders, adding passing lanes and wildlife enhancement structures. Project will also replace the culvert at the East Fork Moose River with a bridge, and install a pedestrian undercrossing for the Skyline Trail
