WHAT IS A STIP?

The Statewide Transportation Improvement Program (STIP) is a schedule of federally funded surface transportation projects and their phases (environmental , design, right-of-way, and construction) anticipated in the next 4 years. The Alaska Department of Transportation & Public Facilities (ADOT&PF) develops the STIP through an extensive public process. Within federally designated Metropolitan Planning Areas, there is also a separate Transportation Improvement Program (TIP) that is developed through a process overseen by the State and the local governments. The Metropolitan Planning Organization for the Anchorage and Chugiak/Eagle River area is called Anchorage Metropolitan Area Transportation Solutions (AMATS). 
CONSTRUCTION PROJECT HIGHLIGHTS

- West Dowling Road Phase I Construction Underway Project will widen to 5 lanes and extend West Dowling Rd from Old Seward Hwy to C St. Replace Campbell Creek Bridge, install a new traffic signal at C Street and re-align the Campbell Creek Trail to go under the new bridge. <u>http://alaskanavigator.org/projectDetails.php?id=10</u>
- Seward Highway: Dowling to Tudor section in Construction This project will widen the New Seward Hwy from 4 to 6 lanes from Tudor to Dowling, provide improvements to both frontage roads (Homer and Brayton Drives) to include multi-use trails and replace bridges over Campbell Creek. This project is scheduled to be complete by June 2014. <u>http://sewardhighway.info/</u>
- Birchwood Airport Runway Pavement Rehabilitation This project will resurface the Birchwood Airport in an effort to better maintain and manage airport pavements. Paving to be completed this Summer. <u>http://dot.alaska.gov/creg/birchwood/</u>



PLANNING & DESIGN EFFORTS

AMATS MTP Cover



- **Metropolitan Transportation Plan (MTP) Approved** The AMATS Policy Committee on May 3, 2012 met and approved the 2035 Metropolitan Transportation Plan. This Plan guides almost \$4 billion in transportation network improvements between 2012 and 2035—from new road connections, additional buses, sidewalks, bike lanes, trails to better streets and improved intersections. http://www.amatsinfo.org
- Abbott Road in Design ADOT&PF is developing alternatives for improvements to two miles of Abbott Road between Lake Otis Parkway and Birch Road in Anchorage. The portion of Abbott Road between Elmore Road and Birch Road has the highest crash rate of any Anchorage Hillside collector. Drivers of this corridor currently experience delays and long queues during their morning and evening commutes. <u>http://www.abbottroadrehab.com/</u>

MAINTENANCE & OPERATIONS INFORMATION

- Eklutna Overpass Girder Replacement and Repair Glenn Highway traffic will be routed around Eklutna Overpass via ramps from June 8-10.
- M&O staff have transitioned from winter to summer operations after the heaviest snowfall on record here in Anchorage. This past winter's expenses for snow removal exceeded recent yearly averages by approximately 30%, and nearly maxed out the capacity of ADOT&PF's three Anchorage area snow dumps.
- Street Sweeping New and more stringent EPA regulations required an increase in street sweeping, storm drain cleaning and sand storage for ADOT&PF in 2012. To ensure proper compliance with the regulations M&O has established a strict street sweeping schedule for Anchorage.
