

DBE REIMBURSEMENT PROGRAM

DBE firms may receive assistance to cover cost of training or consultation and/or association fees/dues that enhance the management or expertise of your DBE. A 50% reimbursement program is available to individuals of qualifying DBE firms. Under this program firms may be reimbursed for 50% tuition or other costs (up to \$1500.00 per calendar year) for business or technical training, workshops, consulting services, and professional association fees/dues. Small Business Development Center core classes are reimbursed at 90%.

REIMBURSEMENT REQUIREMENTS

-  Your DBE firm must be actively pursuing ADOT&PF FHWA projects or be in its first year of certification.
-  Training/assistance or professional fees/dues must be business related.
-  Individuals who qualify must be (1) DBE business owners or (2) On-site representative who are listed in the DBE firm' s CRO file for at least one year.

SHORT TERM LENDING PROGRAM (STLP)



The Short Term Lending Program (STLP) provides revolving lines of credit to

help you meet costs arising from transportation related contracts. Collateral required for this assistance is provided from the proceeds of the contract. Borrowing under the lines of credit will meet the short term costs of performing the contracts.

FINANCIAL SERVICES

We provide you with direct access to various agencies and financial institutions for all your financial needs. The U.S. Department of Transportation (USDOT), Office of Small and Disadvantaged Business Utilization (OSBDU) through its Short Term Lending Program financial institutions partner with OSBDU to administer this important service.

STLP ELIGIBILITY REQUIREMENTS

-  The applicant must hold a current, valid certification as a DBE or be certified under one of the qualified Small Business Administration program.
-  The firm must possess or be seeking a transportation related contract that supports the application.
-  The firm must have at least three (3) years of past performance history.
-  The firm must be current on all federal and state taxes.

FREE WORKSHOPS / TRAINING



The Civil Rights Office (CRO) DBE Support Services Office frequently offers workshops and training free of charge to certified DBE firms.
