eCFR :: 49 CFR Part 23 -- Participation of Disadvantaged Business Enterprise in Airport Concessions

1. **Purpose:** The regulation aims to establish guidelines for Disadvantaged Business Enterprises (DBEs) participating in Department of Transportation (DOT) federally-assisted contracting programs.
2. **Scope:** Applicable to DOT recipients, subrecipients, and contractors that receive DOT financial assistance and engage in contracting activities.
3. **Definitions:** Provides definitions for terms used within the regulation, including DBEs, DOT-assisted contract, and other relevant terms.
4. **DBE Program Requirements:** Outlines requirements for establishing and implementing a DBE program, including certification, program eligibility criteria, and monitoring procedures.
5. **DBE Participation:** Specifies requirements for the participation of DBEs in DOT-assisted contracts, including contract goals, good faith efforts, and counting credits.

6. **Certification Standards:** Sets forth standards and procedures for certifying DBEs, including eligibility criteria and certification application processes.
7. **Goal Setting:** Describes the process for establishing overall and contract-specific DBE participation goals, considering various factors such as local market conditions and the availability of DBEs.
8. **Good Faith Efforts:** Details the actions that prime contractors must take to demonstrate their efforts to meet DBE participation goals, including outreach, solicitation, and documentation requirements.
9. **Reporting and Recordkeeping:** Requires recipients, subrecipients, and contractors to maintain records and submit reports related to DBE participation, compliance efforts, and contract performance.
10. **Compliance and Enforcement:** Establishes procedures for monitoring and enforcing compliance with DBE program requirements, including investigation of complaints and sanctions for non-compliance.

Goals of the ACDBE program

- To ensure nondiscrimination in the award and administration of opportunities for concessions by airports receiving DOT financial assistance;
- To create a level playing field on which ACDBEs can compete fairly for opportunities for concessions;
- To ensure that the Department's ACDBE program is narrowly tailored in accordance with applicable law;
- To ensure that only firms that fully meet this part's eligibility standards are permitted to participate as ACDBEs;
- To help remove barriers to the participation of ACDBEs in opportunities for concessions at airports receiving DOT financial assistance; and
- To provide appropriate flexibility to airports receiving DOT financial assistance in establishing and providing opportunities for ACDBEs.

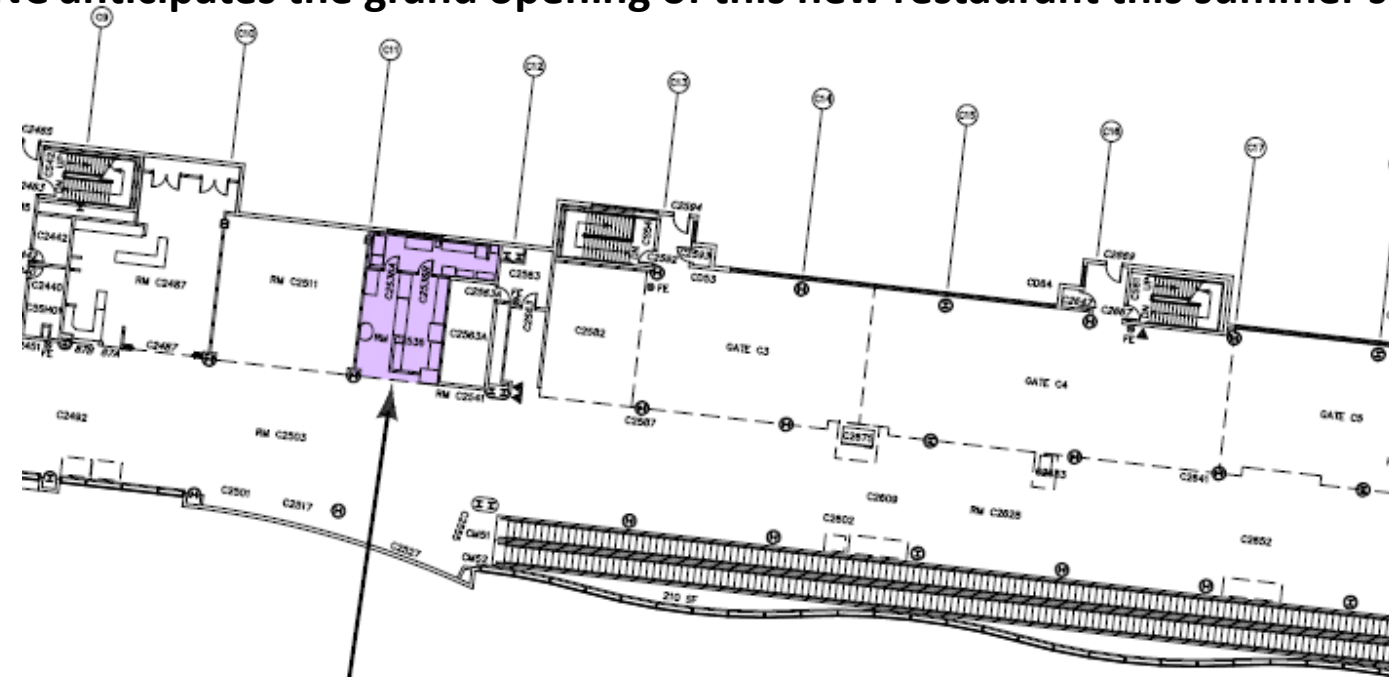

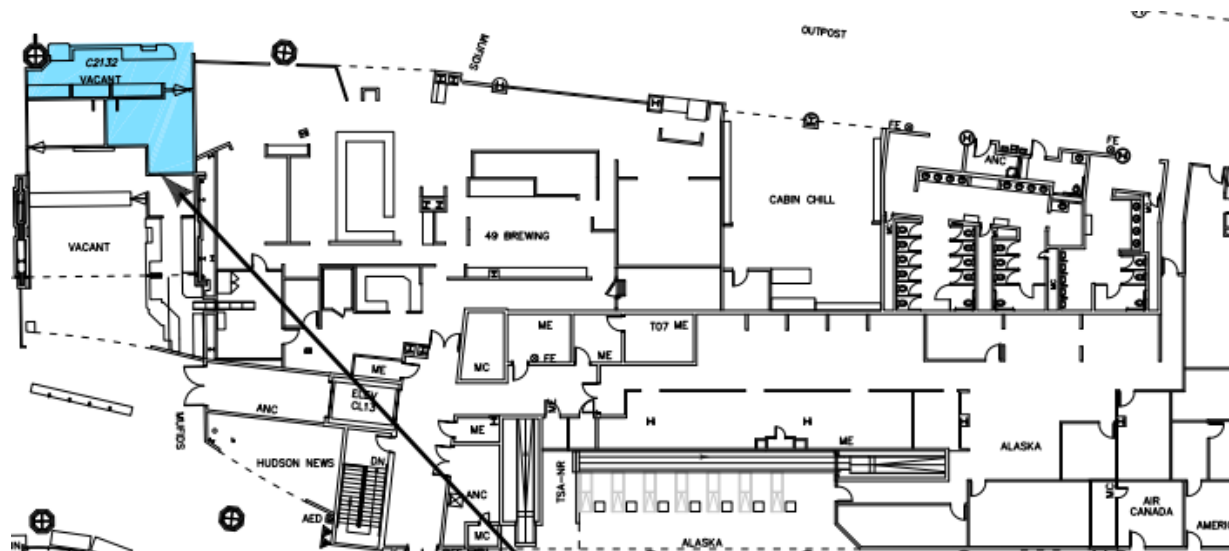
