# Steese Expressway / Johansen Expressway Interchange

The Alaska Department of Transportation & Public Facilities (DOT&PF), in cooperation with the Alaska Division of the Federal Highway Administration, is proposing an interchange at the Steese Expressway and the Johansen Expressway intersection located in Fairbanks, Alaska.

### **Purpose & Need**

The Steese and Johansen Expressways are principal arterials in Fairbanks and the intersection is ranked in the top 10 for entering vehicle volume in Fairbanks. The Steese/Johansen intersection is a critical node for commercial traffic heading to the North Slope from Canada, Valdez, and Anchorage. The area surrounding the intersection has experienced substantial commercial and residential development since the early 2000s. Traffic volumes within the project area are among the highest in the City of Fairbanks.

The purpose of the Steese-Johansen project is to enhance motorized and non-motorized mobility and user safety at the Steese/Johansen intersection and within the influence area of the intersection. Engineering analysis and public scoping identified four primary operational and safety concerns:



Pedestrian and bicycle safety



Pedestrian delay



Proximity of Farmers
Loop Road




Vehicle delay

## **Project Background**

The Diverging Diamond Interchange (DDI) with a temporary detour connection is the Preferred Build Alternative for construction. The pathway connection will be constructed between the Northside Boulevard and Farmers Loop Road Extension to provide enhanced bike connectivity between the Johansen and Farmers Loop separated paths. The project will close City Lights Boulevard north of the Lazelle Road intersection, terminating it in a cul-de-sac near the Birch Hill Cemetery entrance. A noise analysis identified the potential need for a noise wall along the east side of the Steese Expressway between Trainer Gate and the Johansen Expressway. The adjacent intersections of Farmers Loop Road/Steese Expressway and Old Steese/Johansen Expressway will receive minor optimizations to align with the new traffic pattern. #### **Schedule**

The preferred alternative was selected, completing the environmental document in 2021. The team kicked off the right-of-way phase in 2023, contacting impacted owners and working on appraisals (see schedule below). We are continuing to progress design and are working with a Contractor to develop a construction phasing plan. Construction is not anticipated to start before 2026 and will likely take 3 seasons.
