Alaska Department of Transportation and Public Facilities (DOT&PF) proposes a federally funded project that would enhance pedestrian and bicycle facilities along Glacier Highway, between Sunny Drive and Vanderbilt Hill Road.

Glacier Highway, in the Lemon Creek area, is heavily traveled by pedestrians and bicyclists despite inadequate facilities for both. The purpose of this project is to make the road more accessible to pedestrians, including those with disabilities and to improve mobility of bikers and transit users. The proposed project would

- Add a roundabout to the Renninger Street intersection with pedestrian crossings to either side of Renninger Street
- · Remove the Pedestrian Beacon crossing at Walmart and replace it with a two-stage crossing with a Rectangular Rapid Flashing Beacon
- · Add pedestrian crossings and raised medians at other locations throughout the corridor
- Add a sidewalk on the seaward side and lighting to both sides of the roadway along the entire corridor
- · Add a bicycle-only crossing at the intersection between Vanderbilt Hill road and Glacier Highway
- · Relocate and improve bus pullouts and shelters along corridor
- · Consolidate highway access drives between Davis Avenue and Vanderbilt Hill Road
- · Add a traffic signal at Davis Avenue
- · Replace CBJ sanitary sewer force main between Anka Street and Davis Avenue
- · Relocate and upgrade CBJ sanitary sewer lift station across from Gruening Park

The project improvements would require permanent acquisition of portions of privately and publicly owned properties for right-of-way (ROW). This would require permanent acquisition of approximately 64 partial parcels with some duplication.

Construction is projected to begin in 2017

Development of this proposed project would follow a process required by the National Environmental Policy Act (NEPA). Based on project location and scope of work, the environmental document would be a categorical exclusion (CE). Possible affected resources include historic properties, Waters of the U.S., and there may be
