The Alaska Department of Transportation and Public Facilities is proposing to reconstruct the segment of Sawmill Creek Road between the Roundabout and Intersection of Jeff Davis Street

The project would

- · Reconstruct pavement surfaces
- · Install sidewalks to ADA specifications.
- · Install curbs and curb ramps
- · Relocate utility poles out of the sidewalk
- · Replace storm drain system
- · Install a concrete median at the DeGroff Street intersection to better delineate traffic
- · Install signage (for drivers and pedestrians)
- · Add road striping

The proposed project is expected to construct around April 2019.

Below is the proposed schedule

- · Final Project Review July 2018
- · Advertise Project September 2018
- · Construction April 2019

The design team will be present at the open house to answer questions, and note public comments or concerns about possible effects. This is an ideal time to make comments since the project design is still in development and has not been finalized. Your attendance and comments would be appreciated.
