# INTRODUCTION

In January 2011, this Yakutat Coordinated Transportation Plan was drafted and approved in February 2011. The Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) act requires that when federally funded grants are used to provide vehicles and other transportation-related items, the following must happen:

- 1) documented evaluation of existing transportation providers;
- a community needs assessment documenting the unmet transportation needs/duplications in human service agency and public transportation service; and
- 3) community outreach to encourage participation from all of the local stakeholders that represent the targeted populations.

The following federal funding grants are allocated as part of SAFETEA-LU. They are: Transportation for Elderly Persons and Persons with Disabilities (Section 5310). They require participation in the Community Coordinated Transportation Plan in order to be considered for funding. Each of these federal funding grants requires a match from local, state, or any non-U.S. DOT source.

The Federal Transit Authority (FTA) defines a "coordinated public transit-human service transportation plan" as a plan that "identifies the transportation needs of individuals with disabilities, older adults, and people with low incomes, that provides strategies for meeting those local needs, and prioritizes transportation services for funding and implementation."

This plan will need to be updated every five years. Every grant cycle the community coordinated group must prioritize the projects they would like funded. Then the list must be approved by the local government in a public meeting. Once a community has a plan that the local governing body adopts, the State will post it on their website for others to reference.

# **1.0 COMMUNITY BACKGROUND**

# Location

Yakutat is isolated among the lowlands along the Gulf of Alaska, 225 miles northwest of Juneau and 220 miles southeast of Cordova. It is at the mouth of Yakutat Bay, one of the few refuges for vessels along this stretch of coast. The Hubbard and Malaspina Glaciers are nearby. Its boundaries are the Canadian border to the north, Cape Suckling to the west, and Cape Fairweather to the east. The Yakutat Borough is within and surrounded by the Tongass National Forests, Wrangell St. Elias National Park and Preserve, and Glacier Bay National Park and Preserve. It is landlocked.

Yakutat has a maritime climate characterized by relatively mild, often rainy weather. Summer temperatures range from 42 to 60 °F and winter temperatures from 17 to 39 °F. Yakutat receives some of the heaviest precipitation in the state, averaging 132 inches of precipitation and 219 inches of snowfall each year.

# **Economy**

Yakutat's economy is dependent on fishing, fish processing, and government. In 2009, 156 residents held commercial fishing permits. North Pacific Processors is the major private employer. Recreational fishing opportunities, both saltwater and freshwater, are world-class. Most residents depend on subsistence hunting and fishing. Salmon, trout, shellfish, deer, moose, bear, and goats are harvested.

# History, Culture and Demographics

Yakutat has a diverse cultural history. The original settlers are believed to have been Eyak-speaking people from the Copper River area who were conquered by the Tlingits. Yakutat means "the place where the canoes rest." In the 18th and 19th centuries, English, French, Spanish, and Russian explorers came to the region. Fur traders were attracted to the region's sea otters. The Russian-American Company built a fort in Yakutat in 1805 to harvest sea otter pelts. Because the Russians would not allow local Tlingits access to their traditional fisheries, a Tlingit war party attacked and destroyed the post. In 1884 the Alaska Commercial Company opened a store in Yakutat. By 1886, the black sand beaches in the area were being mined for gold. In 1889 the Swedish Free Mission Church had opened a school and sawmill in the area. A cannery, sawmill, store, and railroad were constructed beginning in 1903 by the Stimson Lumber Company. Most residents moved to the current site of Yakutat to be closer to the cannery, which operated through 1970. During World War II, a large aviation garrison and paved runway were constructed. Troops were withdrawn after the war, but the runway is still in use. The City of Yakutat was formed in 1948, but in 1992 the city was dissolved and a borough was organized for the region.

A federally-recognized tribe is located in the community -- the Yakutat Tlingit Tribe;

Central Council Tlingit & Haida Indian Tribes of Alaska. The population of the community consists of 46.8% Alaska Native or part Native. The area maintains a traditional Tlingit culture with influences from the original Eyak Athabascans, as well as Russian, English, and American traders and miners. Fishing and subsistence activities are prevalent. During the 2000 U.S. Census, total housing units numbered 499, and vacant housing units numbered 234. Vacant housing units used only seasonally numbered 178. U.S. Census data for Year 2000 showed 440 residents as employed. The unemployment rate at that time was 7.76 percent, although 28.22 percent of all adults were not in the work force. The median household income was \$46,786, per capita income was \$22,579, and 13.54 percent of residents were living below the poverty level.

# Facilities, Utilities, Schools and Health Care

Water is derived from four wells and is treated and piped to all homes and schools in the community. Several wooden storage tanks provide pressure to the water system. Piped sewage receives primary treatment; a secondary treatment facility is nearing completion. A private firm collects refuse, and the borough operates the unpermitted landfill. Electricity is provided by Yakutat Power, Inc., using four diesel-fueled generators. There is one school located in the community, attended by 111 students. Local hospitals or health clinics include Yakutat Community Health Center. The clinic is a qualified Emergency Care Center. Emergency Services have limited highway, limited marine, coastal, airport and floatplane access. Emergency service is provided by volunteers and a health aide. Auxiliary health care is provided by Yakutat Volunteer EMS/Rescue (907-784-3206).

# **Transportation**

The Yakutat airport is owned, operated, and maintained by the State of Alaska. It is the only facility through which regularly scheduled transportation access for Yakutat residents is available, as there is no road connecting it with other towns and ferry service is infrequent. Daily commercial jet service is available going both north to Anchorage and south to Juneau. The airport has two jet-certified runways; a single 7,745-foot by 150-foot primary runway oriented east/west and a 5,085-foot by 150-foot crosswind runway oriented north/south. It is located three miles southeast of town, and a seaplane base is available one mile northwest.

Through the Conditions and Needs Assessment Report and other documents, an Airport Master Plan is in effect to improvement projects which were identified for the airport to bring it up to standards and ensure it provides a safe operating environment over the life of the plan.

The U.S. Forest Service owns five airstrips in the vicinity, and the National Park Service operates one at East Alsek River. The borough operates the state-owned boat harbor and the Ocean Cape Dock. Monti Bay is the only sheltered deep water port in the Gulf of Alaska. Barges deliver goods monthly during the winter and more frequently in summer.

Air charters are readily available for flying to fish camps and hunting lodges around Yakutat.

Some river travel for substance and commercial fishing during the summer is also available commercially.

# Description of Current Service:

- If individual citizens need transportation, there is one part-time and one fulltime private taxi service and rental cars. Elders ages 60 and over may reserve rides through the Yakutat Senior Center Transportation Program Monday through Friday from September through May. In certain situations, the Social Services Division of the Yakutat Tlingit Tribe may also provide transportation to elders or tribal members with disabilities of any age. The Yakutat School District (784-3371) has one school bus and may use the bus to transport students to school related sports events within the district.
- The <u>Alaska Marine Highway</u> offers limited sailings to Juneau with a week between arrivals and departures. There is no ferry terminal. Reservations and ticketing for passengers and vehicles is done through the central reservations office in Juneau (1-800-642-0066). Passengers embark from the Yakutat City Dock. (Passengers may refer to the Alaska Marine Highway website for specific information).

• <u>Alaska Marine Lines</u> maintains an office. A barge is scheduled to arrive and depart monthly throughout the year.

- <u>Air taxi flights and charter boats</u> are available for transportation to near-by hunting and fishing lodges.
- <u>Rental vehicles</u> are readily available by contacting individual lodge operators.
- There is a major airport runway. Yakutat has a state-owned lighted paved runway and accommodates <u>Alaska Airlines</u> passenger and cargo flights daily as well as private aircraft.

# **Current Vehicle Inventory**

- One taxi individually owned and operated in good condition (general public) and available eight months of the year. A new full-time taxi service with one vehicle is now in operation.
- Two Caravans owned by the Yakutat Senior Center. The older one is in poor condition. The newer one is not sturdy enough for winter driving and gets gravel in the wheel-chair accessible grooves due to the unpaved roads.
- The Yakutat Tlingit Tribe has one company vehicle. Staff provides rides to the elderly and tribal members with disabilities on a limited basis.
- The School District contracts with a private business for one bus to transport students to and from school and on occasion to school-related functions.
- There are police and patrol vehicles but no ambulances or EMT vehicles and no fire trucks.
- There are no tourism vehicles such as large busses at this time, but have been in the past.

# **Barriers to Providing Transportation**

- There is only one mechanic shop in Yakutat and service is only available when the one mechanic is available. Ordering and receiving parts can take a long time.
- The most accessible transportation is the senior center caravan mini-fleet, but a citizen must be at least 60 to be eligible for rides.
- The senior transportation program only operates nine months of the year.
- The mileage on the 2001 Caravan as of November 2010 was 48,214. Due to Yakutat's road conditions, wear and tear is severe. Even with major repairs completed in 2009, the van began needing additional repairs by 2010. Safety issues may arise.

• Rental vehicles are prohibitively expensive and are only available through the Mooring Lodge, primarily in the summer.

# Funding Sources

- The existing funding source is primarily the Yakutat Senior Center budget which includes 3% funding contributed by the City and Borough of Yakutat and 2% from individual donations.
- The potential funding sources for increased services are limited to the Alaska State Department of Transportation, the City and Borough of Yakutat, Yakutat Tlingit Tribe, and Yak Tat Kwaan.
- Elders can usually get same day rides though it's best if they call the Yakutat Senior Transportation Program at least 24 hours in advance. There may be some restriction of service due to winter road conditions. Tourists should call in advance to reserve rental vehicles.

# 4.0 GAPS IN SERVICE

- Door-door service is available on all Caravan rides. Riders may provide an escort if needed.
- Transportation assistance is provided for trips to the grocery store, post office, senior center, clinic, community events at high school or Yakutat Tlingit Tribe building, local public beach, airport, barge, and ferry terminal. Seniors can request to go anywhere in the area where roads are not too poor.
- There are certain times of the day or week when people cannot get transportation assistance if they need it. The Senior Center Caravan is available only from 8:30 to 3:00 Monday through Friday, nine months of the year.
- There may not be enough service at night and on the weekends. Service is only available during the week days. Taxi service is available for weekends and evenings.
- The Caravan service is never overbooked.
- The group that most needs transportation assistance but are not eligible for existing programs are those under 60 with disabilities.
- The service is affordable. Fares are only by donation only.
- The village elders' transportation needs are met through the Yakutat Senior Center transportation program, and in an emergency by YTT staff and family members.
- Riders can make multiple stops if scheduled in advance.
- Riders can get help with shopping bags, luggage, or similar packages when using the caravan service.
- Anyone over 60 can ride once a year or every day service is available.

# 4.01 NEEDS ASSESSMENT

The information below was gathered on January 12-13, 2011 from seniors who receive home delivered meals, seniors who came to the Yakutat Senior Center meeting, and the general public and stakeholders at a public meeting held in the conference room at the Yakutat Tlingit Tribe offices.

- 1. Replace the 2001 Caravan with a new 4-wheel drive vehicle suitable for inclimate weather and poor road conditions.
- 2. Expand transportation options to include some evening and weekend hours in order to provide seniors with rides to public meetings, clinic appointments, subsistence activities such as visits to fish camps, berry picking, and sea weed gathering.
- 3. Research the need for a DOT "Purchase of Services" grant in order to expand transportation options to persons under 60 with disabilities.
- 4. Install a communication device in each of the Yakutat Senior Center vehicles.
- 5. Apply for a grant to fund an elder advocate to help elders know their transportations options. (Research indicates there has to be a minimum of 50 subsidized housing units in order to apply for a ROSS grant.)
- 6. Research more funding for transportation.
- 7. Keep drivers' CPR/First Aide training up- to -date.
- 8. Private sector support for better vehicle maintenance availability.
- 9. Research the feasibility of getting more main roads paved.
- 10. Increase the frequency of ferry runs and advocate for lower Alaska Airline airfares.

# 5.0 STRATEGIES TO ADDRESS THE IDENTIFIED NEEDS

# **Prioritized List of Strategies**

Public Meeting : 2011 Yakutat Coordinated Transportation Plan

# 1. New Caravan for Yakutat Senior Transportation Program

The Regional Coordinator will submit a "Replacement Vehicle Grant Application" to the Alaska Department of Transportation and request the 20% match through Capital Appropriations. The grant must be submitted by February 11, 2011.

# 2. Expanding Passenger Service

Research regarding applying for a FY 2012 DOT Purchase of Services grant recommends tracking the approximate number of rides that would actually be needed for a year prior to applying. This grant will allow for rides of persons with disabilities and for extended hours of service. It will require a 20% funding match which may be secured, in part, from local entities. An alternative for the coming summer of 2011 is for the Yakutat Senior Center and one of the local entities to develop a Memorandum of Agreement to coordinate limited transportation opportunities for elders.

# 3. Communication Device

The Yakutat Senior Center Site Manager will experiment with a communication device for the van prior to the end of the fiscal year, June 30, 2011.

# 4. Travel Training

A travel training guide is being developed and the Yakutat Senior Center Site Manager will work with the Yakutat Tlingit Tribe to identify elders who would like to ride the van but who need some assistance in beginning the process. Yakutat does not meet one of the conditions necessary to apply for a ROSS grant to support an elder advocate. There must be at least 50 subsidized housing units available in order to apply.

# 5. Transportation Funding Opportunities

The Southeast Senior Services Regional Coordinator will pass on any new information regarding transportation funding opportunities to the Yakutat Tlingit Tribe and the City and Borough of Yakutat.

# 6. CPR/First Aide

The Yakutat Senior Center Site Manager is currently working to secure CPR/First Aide training to update drivers.

- 7. There is currently no known strategy for the problems related to the limited availability of vehicle maintenance.
- 8. Researching the feasibility of getting more main roads paved is a local issue that needs further discussion and planning.
- 9. Increasing the frequency of ferry runs and advocating for lowering Alaska Airline airfares are local issues that need further discussion and planning...

# Projects for Implementation by Priority

The projects to be considered for implementation in FY 11 and FY 12 (January 2011 through June 2012) are the first four listed below in order of priority. This is a priority of projects the community would like to accomplish in the next 5 years. All projects are related to a strategy. This list will become a standalone document that must be updated and approved every grant cycle. This will allow the community to change the project list without updating the entire plan.

1. Travel Trainer: The objective of this project is to increase the understanding and awareness of available transportation to Alaska Native elders. The applicants may be Southeast Senior Services or the Yakutat Tlingit Tribe. A travel training plan (see Appendix C) will be developed and the Yakutat Senior Center Site Manager will work with the Yakutat Tlingit Tribe to identify elders who would like to ride the van but who need some assistance in beginning the process.

2. Replacement Vehicle: The objective of this project is to continue to provide safe, courteous door-to-door transportation to Yakutat's elders. The applicant is Southeast Senior Services. The Regional Coordinator will file a Replacement Vehicle grant application with the Alaska Department of Transportation and will request the 20% match through a Capital Appropriation grant request. The application will be filed by February 11, 2011.

3. Expansion of Rides: Through an MOU with either YTT or the City and Borough of Yakutat, provide limited rides for elders to clinics and special events in June, July, and August using a substitute driver and the Yakutat Senior Center Transportation vehicles. Track the need for rides for the next 12 months.

4. Increase Passenger Safety. The Yakutat Senior Center Site Manager will: 1) experiment with a communication device for the van prior to the end of the fiscal year, June 30, 2011; and 2) work to secure CPR/First Aide training to update drivers' certifications.

5. Increase Awareness of Funding Opportunities. The Southeast Senior Services Regional Coordinator will pass on any new information regarding transportation funding opportunities to the Yakutat Tlingit Tribe and the City and Borough of Yakutat.

6. There is currently no known strategy for the problems related to the limited availability of vehicle maintenance.

7. Researching the feasibility of getting more main roads paved is a local problem that needs further discussion and planning.

8. Increasing the frequency of ferry runs and advocating for lowering Alaska Airline airfares are local problems that need further discussion and planning.
