<p><b>Estimated Funding Sources and Funding Available</b></p>	<ul style="list-style-type: none"> <li>• \$268,602 – Rural FTA Section 5310: Enhanced Mobility of Seniors and Individuals with Disabilities</li> <li>• \$270,000 – Alaska Mental Health Trust Funds (AMHT)</li> <li>• \$900,000 – GF/MH Coordinated Transportation Capital</li> </ul> <p>\$1,438,602 Total (Estimate-Does not include Small Urban or carry-over funds)</p>
<p><b>Eligible Projects and Match Rates</b></p>	<p>Eligible projects must directly serve the target populations of elderly, disabled, or Alaska Mental Health beneficiaries (those with mental illness, developmental disabilities, Alzheimer’s, other dementias, chronic alcoholism, or traumatic brain injury):</p> <ul style="list-style-type: none"> <li>• Operating (50/50 match rate, fares cannot be counted toward local match if applying for FTA 5310 funds)</li> <li>• Capital (80/20 match rate)</li> <li>• Purchase of Services (80/20 match rate) <i>Must be purchased transportation services with a third-party vendor, and cannot be operated by the applicant.</i></li> </ul>
<p><b>Eligible Applicants</b></p>	<p>Applicant must have submitted an Intent to Apply and received notification from ACT of verification of eligibility based on the following:</p> <ul style="list-style-type: none"> <li>• The applicant is located in a community that has a current coordinated public transit-human services transportation plan; and</li> <li>• Is a private nonprofit organization, OR</li> <li>• Is a state or local government authority (including tribal) that is approved by the State to coordinate services for seniors and individuals with disabilities; and/or certify there are no non-profit organizations readily available in the area to provide the service.</li> </ul>
