# What all FHWA, FAA and FTA recipients must do to operate the Federal DBE Program and ACDBE Program

- Set overall three-year goals for DBE participation on FHWA-, FAA- and FTA-funded contracts
- Consider whether it can achieve overall DBE goal solely through neutral means
- Determine the portion of the overall goals, if any, to be met through race-conscious means such as DBE contract goals
- In states (like Alaska) that are within Ninth Circuit Court of Appeals ... consider whether there is evidence of discrimination, by DBE group, to support inclusion in any race- or gender-based programs




# Introduction to disparity studies

Analyze any disparities between minority-owned business enterprises (MBEs) and woman-owned business enterprises (WBEs) in terms of:

- Utilization (share of DOT&PF dollars going to these firms)
- Availability (expected share given a level playing field)

## Calculate availability through:

- Online and phone survey of firms potentially available for DOT&PF work
- Contract-by-contract availability analyses by group of firms, accounting for type, size and location of work
- Dollar-weighting of results to calculate overall availability
