**Supervision:** I understand that while reasonable measures will be taken to ensure the safety of participants, it is ultimately my responsibility to ensure that my child behaves responsibly and follows all instructions given by event staff and supervisors.

**Release of Liability:** I hereby release, discharge, and hold harmless State of Alaska DOT&PF Civil Rights Office, its officers, directors, employees, volunteers, and agents from any and all claims, demands, causes of action, damages, or liabilities that may arise out of or in connection with my child's participation in the construction event, including but not limited to any injuries, losses, or damages sustained as a result of negligence or misconduct.

**Medical Treatment Authorization:** In the event of any injury or medical emergency involving my child during the construction event, I authorize event staff to seek and consent to any necessary medical treatment on behalf of my child. I understand that every effort will be made to contact me in such situations, but that timely medical treatment may be necessary and take precedence.
