The market area is the geographical area in which the substantial majority of firms which seek to do concessions business with the airport are located and the geographical area in which the firms receive a substantial majority of concessions related revenues are located. It was considered reasonable based on past history and the unique geographical location of Anchorage that the Municipality of Anchorage, the state of Alaska, as well as the Nation should be used as the market area for the above reference concessions.

Base of Goal

Normally calculations for the base of the goal the Alaska DOT&PF would consider the previous 3 years of gross concession receipts and the projected potential concession revenue (gross receipts) three years into the future including upcoming new opportunities. Due to the downtick during the COVID years it was considered reasonable to take the FFY 2022 gross receipts that reflected pre-COVID numbers and apply the typical 2.5% escalation for the FFY 2024-FFY 2026 period.

The concession opportunities anticipated during this goal period are those reflected in the market area chart on page one (1), with estimated annual average of gross receipts of \$47,729,097.00. The FY 2022 gross receipts indicated a return to pre-COVID numbers, and the FY 2023 gross receipts are on track at an estimated \$46,500.000.00. An annual review of gross receipts will be made, and adjustments made if necessary. During the FY 2024-2026, ANC Airport anticipates five (5) new Non-Car Rental Concession Agreements for the Non-Car Rental Concession Program:

ANC Airport anticipates that the revenue from C2132 and C2536 will each exceed \$200,000/year. There isn't enough data on S1843, SA1483 and SA2610 for the ANC Airport to make a prediction on additional revenues.

The following are not included in the total gross receipts for concessions: (a) the gross receipts of car rental operations, (b) the dollar amount of a management contract or subcontract with a non-ACDBE, (c) the gross receipts of business activities to which a management contract or subcontract with a non-ACDBE pertains, and (d) any portion of a firm's estimated gross receipts that will not be generated from a concession.

Step 2: 23.51(d)

After calculating a base figure of the relative availability of ACDBEs, we examined evidence to determine what adjustment if any was needed to the Step 1 base figure in order to arrive at the overall goal. It was considered reasonable to examine past performance to establish if any adjustment needs to be made. See past history below.

The next step was to determine if any adjustment might be needed to the Base Figure. It was determined that the Median of the three years was 4.67% and it was felt that the Base Figure should be adjusted to cater for this variance.

A summary of this analysis yields the following:

Median Percentage 4.67%
Base Figure
$$\frac{+0.22\%}{4.89\% \div 2} = 2.45\%$$

Satisfied that the Median Percentage was valid, the final step in the comparison was the development of a simple average of the Base Figure and the Median Percentage to establish a final percentage. The result of this was 2.45%. It was felt that the Base Figure of 0.22% should be adjusted for this variance. The Average Percentage of 2.45% is established as the non-car rental ACDBE goal for FFY 2024-FFY 2026.

Public Participation

Consultation: Section 23.43.

The goal setting process used by recipients to establish their annual overall goal submitted to the operating administrations for approval includes consultation with minority, women's and ACDBE community organizations, and other officials or organizations which could be expected to have information concerning the availability of ACDBEs and non-ACDBEs. This consultation process is also intended to gather information concerning the effects of discrimination on opportunities for ACDBEs and establishing a level playing field for the participation of ACDBEs. The Alaska DOT & PF maintains a list of DBE/ACDBEs and non-DBE companies that were utilized to provide invitations to the stakeholder consultation. The outreach for the stakeholder consultation was as follows: Email notification of the proposed ACDBE goal and information regarding the Public Consultation meeting were sent on September 14, 2023 to DBE/ACDBEs, car rental concessionaires, DBE/ACDBE conference attendees, AUCP members, Civil Rights Office Partners, and Alaska DOT&PF airport staff. Further, the ANC ACDBE goal methodology was covered during the monthly Resource Development Meeting that the Civil Rights Office attends at the Procurement Technical Assistance Center. Additionally, information regarding consultation for the ANC ACDBE goal methodology was posted on the Alaska DOT&PF Facebook page and to the CRO website. Prior to submitting the ACDBE goal to the FAA the Alaska DOT&PF consulted with stakeholders on September 20, 2023, at approximately 1:00 pm AKDT, with a question regarding access to the presentation.

Breakout of Estimated Race-Neutral & Race Conscious Participation

Section 23.51

The Alaska DOT&PF will meet the maximum feasible portion of its overall goal by using race-neutral means of facilitating ACDBE participation. The Alaska DOT&PF uses the following race-neutral measures.

- 1. Locating and identifying ACDBEs and other small businesses who may be interested in participating as concessionaires under 49 CFR Part 23;
- 2. Notifying ACDBEs of concession opportunities and encouraging them to compete, when appropriate;
- 3. When practical, structuring concession activities so as to encourage and facilitate the participation of ACDBEs;
- 4. Ensuring that competitors for concession opportunities are informed during pre-solicitation meetings about how the Alaska DOT&PF's ACDBE program will affect the procurement process;
- 5. Providing information concerning the availability of ACDBE firms to competitors to assist them in obtaining ACDBE participation.

Each time the Alaska DOT&PF submits an overall goal for review by the FAA, the Alaska DOT&PF will also submit a projection of the portion of the goal that is expected to be met through race-neutral means and the basis for that projection. This projection is subject to approval by the FAA, in conjunction with its review of the Alaska DOT&PF's overall goal. The Alaska DOT&PF will establish contract goals to meet any portion of an overall goal when the Alaska DOT&PF does not project being able to meet goals using race-neutral means.

We estimate that, in meeting our goal of 2.45%, we will obtain 0.00% of the goal from race-conscious participation and 2.45% via race-neutral participation measures.

Methodology used to Calculate Overall Goal

Goods and Services

As there are no ACDBE car rental concessions in the market area, we can calculate the ACDBE goal by including the purchases from ACDBEs of goods and services used in business conducted at the airport by the car rental agencies. The goal will be developed by considering the ACDBE goods and services opportunity dollar value from purchases of goods and services from ACDBEs as the numerator, and the dollar value from purchases of goods and services from all firms (ACDBEs and non-ACDBEs) as the denominator.

Goal Based on Goods and Services Purchases - Determination:

Upon review of the market, it appears that all or most of the goal is likely to be met through the purchases by car rental companies of vehicles or other goods/services from ACDBEs. This is due to the fact that no certified ACDBE car rental companies exist within the market. As such, the Alaska DOT&PF has structured the goal entirely in terms of the purchases of goods and services.

We determined the goal based on outreach for the purchases of goods and services from certified ACDBE firms and/or potential ACDBE firms in the market area. This basis is in lieu of a goal based upon a percentage of total gross receipts of car rental operations at the Airport. We will make strong efforts to pursue opportunities to meet the goods and services goal. We will continue to consult and work with the Alaska DOT&PF and the Alaska Unified Certification Program (AUCP), our car rental concessionaires at the Airport, similarly situated airports in our region, minority and women businesses in the State, minority serving institutions, local pro-business organizations, and targeted media publications to find prospective ACDBE firms. We will work with our car rental companies to strategize outreach to Alaska DOT&PF and AUCP certified ACDBEs that may be able to provide car rental goods and services, to encourage current vendors who may be eligible for ACDBE certification to apply, and to encourage firms already working at the airport but certified as ACDBE in other states, to apply via the interstate certification process. The Alaska DOT&PF and the AUCP is aware of this requirement and is on board to assist and process certifications as required by 49 CFR Subpart C.

We have the following car rental agencies operating at the airport: Enterprise, Avis, Budget, Hertz, Dollar and Thrifty, National/Alamo, Alaska 4 x 4.

After collaboration and discussion with the Airport, car rental company concessionaires at the Airport stated that the goods and services they may need in the goal period are: Office Supplies, Parking Lot Striping, Tire Wholesaler, Cleaning Supplies, Durable Goods, Fuel Dealers, New Car Dealership, Auto Parts Supplies, Towing, Phone System, Insurance, Accounting, Advertising Agency, Printing, Alarm System, Locksmith, Janitorial Services, General Auto Repair, Auto Body Repair, Auto Glass, Oil Change, Car Wash/Detail, and Computer/office Repair with estimated gross receipts (goods and services purchases) of \$101,446,237 over the next three year period. The below numbers are estimates based on information acquired from the concessionaires. These numbers will not be in agreement with the Uniform Report in the FAA civil-rights-connect portal as at that time Gross Receipts were being submitted.

The Alaska DOT&PF will meet the maximum feasible portion of its overall goal by using race-neutral means of facilitating ACDBE participation. The Alaska DOT&PF uses the following race-neutral measures.

We understand that we will be expected to actually take these steps, and this is not merely a paper exercise.

- 1. Locating and identifying ACDBEs and other small businesses who may be interested in participating as concessionaires under 49 CFR Part 23;
- 2. Notifying ACDBEs of concession opportunities and encouraging them to compete, when appropriate;
- 3. When practical, structuring concession activities so as to encourage and facilitate the participation of ACDBEs;

- 4. Ensuring that competitors for concession opportunities are informed during pre-solicitation meetings about how the Alaska DOT&PF's ACDBE program will affect the procurement process;
- 5. Providing information concerning the availability of ACDBE firms to competitors to assist them in obtaining ACDBE participation; and
