# **Commercially Useful Function**

A Commercially Useful Function (CUF) means a DBE/ACDBE firm must actively perform, manage, and supervise its contracted work using its own resources. This includes overseeing operations, ordering materials, and fulfilling obligations independently. A firm does not meet CUF requirements if it serves only as a pass-through. CUF compliance is essential to maintaining the integrity of DBE participation and meeting federal requirements.

A CUF is performed by Alaska DOT&PF at the beginning and end of a project to ensure compliance.

## **New Firm Orientations**

Newly certified? Attend one of our orientations for DBE/ACDBE firms, designed to set you up for success! In partnership with Alaska APEX Accelerator (federal procurement), these sessions provide valuable insights into the DBE Program, including compliance requirements, support services, and training opportunities. You'll also learn how to actively bid on federally funded projects and navigate the Alaska DOT&PF websites effectively.

From Alaska APEX Accelerator you will gain a clear understanding of how to navigate the federal contracting process, from identifying opportunities to submitting competitive bids.

Monthly Orientations are held on the third Thursday of every month and last for 1.5 hours.
