South Fairbanks Industrial Roads Resurfacing

Northern Region DOT&PF invites you to submit questions and comments about South Fairbanks Industrial Roads Resurfacing project. The Old Richardson Highway (from South Cushman to the Richardson Highway interchange), Easy Street (from the Old Richardson Highway to the Fairbanks North Star Borough Landfill entrance) and Peger Road (from Eula Street to south of the waste water treatment plant) are to be resurfaced. Additional work within the right-of-way of the aforementioned roads scheduled for repaving includes: re-establishment of ditches, removal or vegetation re-growth within currently maintained corridors; in-kind cross culvert replacement, replacement of the at-grade railroad crossing on Peger Road between Tamara and Sanduri Avenues, relocation of utilities within the right-of-way, road re-striping and replacement of existing guardrails and signage.

Construction is currently planned for 2021.

DOT&PF requests information and comments on resources in the project area that may be affected including historic properties, archaeological sites, wetlands, and floodplains.
