A portion of Lot 3, Block 89 of the Fairbanks Townsite as shown on the Map of the Official Survey of Fairbanks Townsite Alaska, according to the survey of said townsite, known as the L.S. Robe Map of 1909, reproduced under the direction of Karl Theile, U.S. Surveyor-General in 1922, Fourth Judicial District, State of Alaska. Fairbanks Recording District

Which lies adjacent to right-of-way lines of Alaska Project No. 000S(413)/61725, delineated as to said tract of land on the plat attached hereto and made a part hereof as page 3 of this instrument and designated as Parcel No. TCE55. Said parcel, containing 422 square feet, more or less, is hereby granted to DOT&PF for the purpose of providing a temporary workspace associated with the construction of road improvements on Noble Street.

The Grantors hereby covenant with DOT&PF that the Grantors have good title to the above-described tract of land, and covenants that DOT&PF shall have quiet and peaceable possession and use thereof during the period of the temporary construction easement.

The period shall begin on the day the contract is awarded and continue for the duration of the project, at which time this easement shall expire and be of no force and effect.
