DESCRIPTION (Use Continuation Sheet 25D-065 as Required)

This Directive is being issued to provide clarification on several site stabilization and material handling questions that have arose. Clarifications are as follows:

- When trenching through Red or Yellow zones for the installation of electrical conduits and structures, or similar work, excavated materials meeting the specification requirements for the placement purpose may be used as trench bedding or backfill. Excess excavated materials may also be placed as Suitable Material in the General Aviation Apron (GAA) Expansion area.
- 2) Temporary or permanent stabilization requirements for Stockpile #1 location shall be in accordance with the project SWPPP, unless otherwise directed by the Engineer.
- 3) Temporary or permanent stabilization requirements for Stockpile #2 location shall be in accordance with the project SWPPP, unless otherwise directed by the Engineer.
- 4) Temporary or permanent stabilization requirements for the GAA Expansion area shall be in accordance with the project SWPPP, unless otherwise directed by the Engineer.
- 5) No encapsulation of GAA Expansion fill slopes is currently required. Stabilize fill slopes upon completion in accordance with the Plans and project SWPPP.
- 6) Trash generated from PFAS handling and management, i.e. boot covers, gloves, temporary plastic covers, etc., may be disposed of as household waste in a landfill as long as they are free of PFAS contaminated materials and soils. An Engineer-issued RFP is forthcoming.
- 7) Suitable Material generated from excavation of Green zones may be placed in either Green, Yellow, or Red zones. Suitable material generated from excavation of Yellow zones may be placed in Yellow or Red zones. Suitable Material generated from excavation of Red zones may only be placed in Red zones.
