

SUBJECT: Airport Specification
Transmittal 02-2

Incorporate as appropriate the *Special Provisions for Airport Construction* dated November 2002 in airport construction contracts advertised after December 1, 2002.

Access the *Special Provisions* from the D&ES Division Intranet Airport Specifications web page.

The *Special Provisions* are:

A 13, Section 10, DEFINITIONS AND TERMS; adds acronyms including CFR and SSAC, and a definition of the Alaska Test Manual with acronym TM.

A 14, Section 20-01, QUALIFICATION OF BIDDERS; The bidder must be registered as an Electrical Administrator, or must employ a person whose Electrical Administrator's license is assigned to the bidder, under AS 08.40 at the time designated for bid opening.

This special provision is to be used when:

The electrical component makes up a majority of the work (i.e. estimated cost of Bid Items in the L-xxx series are more than 50% of the Engineer's estimate of total project cost) on a construction contract (also see 12 AAC 21.310).

A 15, Section 60-03, TESTING AND ACCEPTANCE; Table of Substitute test methods that changes test method numbers in SSAC 07/02 to test methods published in the January 2000 TM. This special provision is to be used with Airport 07/02 until the new ATM is published at which time the table will no longer be needed.
