

Training Program for
Contracts with FHWA
Funding

Effective immediately, use Statewide Special Provision S 99, Form 25A-310 DOT&PF Training Program Request, revised Form 25A-312 Apprentice Employment Report, and revised Form 25A-313 Monthly Training report on federal-aid highway projects identified as eligible by the Civil Rights Office.

Remove Statewide Special Provision S 98 and Forms 25A-312 and 25A-313 and replace with S 99 and revised Forms 25A-312 and 25A-313, and add Form 25A-310, on all currently advertised federal-aid highway projects identified as eligible by the Civil Rights Office.

This rescinds the May 3, 2012 CE Directive, replaces Statewide Special Provision S 98, Form 25A-312, and Form 25A-313, and adds Form 25A-310.
