The attached FHWA, Alaska Division and ADOT&PF Stewardship and Oversight Agreement (S&OA) dated August 21, 2024, is effective immediately for all FHWA authorized projects. The May 27, 2015 directive is superseded.

Program management and project development process steps completed prior to August 21, 2024 in accordance with the 2015 S&OA are grandfathered under the previous guidance. Program management and project development process steps not completed yet must comply with this new S&OA. Coordinate with your region's FHWA Area Engineer to provide informational copies for documentation of project management steps grandfathered under the previous guidance.
