SUBJECT: Chief Engineer's Directive: Revised ASPs G-32.04 & G-33.01

The Alaska Standard Plans Manual (ASPM) is revised effective April 4, 2025, to include the revised ASPs G-32.04 and G-33.01. These Standard Plans modify the installation of MASH bridge rail/transition systems to conform to the Task Force 13 Guide to Standardize Roadside Hardware.

Attached is the new ASP Index, revised ASPs G-32.04 & G-33.01, and their associated Standard Plan Development Reports (SPDRs).
