Use Form 25D-250 Highways (Utility Agreement Template), Appendix A, Form 25D-62B-U, and Form 25D-60B-U for all Utility Agreements with Authority to Proceed to Phase 7 on or after October 1, 2025. These documents have been updated to align with the statewide specification (HSP20-7B) and the form revisions issued through the Chief Engineer's Directive (CED) on October 31. These updates reflect the rescission of the Manufactured Products Waiver and ensure consistency in content, formatting, and overall structure with the current highway specifications and forms.

Additionally, Form 25D-250 Aviation (Utility Agreement Template) has been revised to align with most current FAA and federal guidance, including updated statutory and regulatory references.
